Notice is hereby given that the Board of Directors of Harris County Water Control & Improvement District No. 70 of Harris County, Texas, will hold a regular meeting, open to the public, on **Wednesday, February 4, 2026 at 6:30 p.m.**, at **2935 Foley Road, Crosby, Texas 77532**, within the boundaries of the District, for the purposes of considering and acting upon the following matters:

NOTICE: Harris County Water Control & Improvement District No. 70 ("District") is seeking to contract with Perdue, Brandon, Fielder, Collins & Mott, L.L.P. ("PBFCM") for the collection of delinquent taxes for the tax years 2025 and prior. The District wishes to contract with PBFCM in order to achieve enhanced recovery of delinquent taxes in a cost effective and expeditious manner. There is a need for these services as the District is unable to perform delinquent tax collections due to budgetary constraints and lack of personnel. In addition, delinquent tax collection services are not provided by the District's general counsel. Delinquent tax collection services cannot be performed on an hourly basis as current law provides for collection of a penalty. PBFCM's fee structure is fair; it is a percentage set by the Texas Legislature and represents penalties borne by the delinquent account holders, not the District. PBFCM is an experienced firm with over 40 years of experience in collecting delinquent debts; 12 offices, over 50 attorneys and 400 additional tenured employees. For the foregoing reasons, contracting with PBFCM is in the best interests of the District and its taxpayers.

 - (a) status of inflow and infiltration investigation;
 - (b) approve all necessary maintenance and repair actions;
8. Engineer's Report, including:
 - (a) consider Out of District Service request;
 - (b) status of Sanitary Sewer Rehabilitation project;
 - (c) status of generator project;

- (d) approve pay estimates and change orders, approve easements
 - (e) authorize advertisement for bids, and approve recommendation of award and contracts, as necessary;
9. Billing and Collections Report;
10. Attorney's Report;
11. Adopt Order Calling Directors Election;
12. Comments from the public (3 minutes allotted time per speaker);
13. Such other matters as may come before the Board, including:
- (a) Approve Resolution Adopting Policy Regarding Public Comment at Meeting;
14. Executive Session.

If, during the course of the meeting covered by this Notice, the Board should determine that a closed or executive session of the Board should be held or is required in relation to any agenda item included in this Notice, then such closed or executive meeting or session, as authorized by the Texas Open Meetings Act, Texas Government Code, Chapter 551, as amended (the "Act"), will be held by the Board at the date, hour, and place given in this Notice concerning any and all subjects for any and all purposes permitted by Subchapter D of said Act.
